## Greater Boston Chinese Cultural Association (GBCCA) COVID-19 Safety Acknowledgment -- Liability Waiver and Release of Claims

## **COVID-19 SAFETY INFORMATION:**

## **DUTY TO SELF-MONITOR:**

GBCCA building users agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact GBCCA at gbcca.boston@gmail.com if he/she experiences symptoms of COVID-19 within 7 days after participating with GBCCA.
